





This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on this 28 (Date) of the September (month) 2018 (year) by and between

Sri Vidhya Mandir Arts & Science College, Uthangarai, Krishnagiri

And

Ganesar College of Arts and Science, Melasivapuri, Ponnamaravathy.

Whereas:

First party is named:

Sri Vidhya Mandir Arts & Science College, Uthangarai, Krishnagiri

First Party and Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

The parties' intent to cooperate and focus their efforts on cooperation within area of Skill based training, Education and Research.

Both parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

Now therefore, in consideration of the mutual promises set forth in this MoU, the parties here to agree as follows.

OBJECTIVE

This MOU reflects the participants sincere and genuine intentions to collaborate in specific activities set out hear in pertaining to the research and development of institutions. This collaboration provides opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, to promote research/ continuing education activities between institutions and frequent interactions between both institutions.

SCOPE OF THE MoU

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another. Cooperation shall be carried out through such activities as

- 1. Offering courses and realizing research projects in areas mutually agreed upon by both universities through prior invitation and in accordance with the procedures and expectations established by each Institution and specific department.
- 2. Exchange of information, teaching materials, technological and publications.
- 3. Exchange of undergraduate and graduate students with the objective of enrolling students in Certification Courses/ Value added courses/ Life skills offered on appropriate to their year and area of study.
- 4. Submission of joint research projects for funding to the funding agencies like UGC, government agencies etc on mutually agreeable terms and conditions.
- 5. Provision to share their respective important R&D/ Lab facilities in order to promote academic and research interaction in the areas of corporation
- 6. Shall provide access to the library facilities to Research scholars, Faculty members and Students as per the prevailing rules/ norms in the respective Institution.
- 7. Cooperation in individual projects.
- 8. Jointly organize the lectures, symposium, International conferences and workshops. Help to identify and invite faculty members from the other institution to participate in the organized events.
- 9. Exchange of Students for the skill development programs on emerging technologies in order to bridge the skill gap of students and industries will be carried out.
- 10. Support reciprocity in university extension activities of common interest.
- 11. Exchange of books, publications, study programs, academic projects, course information, seminars, conferences and any other data and information of common interest.
- 12. Providing opportunities for the students to carryout final year projects in collaboration.
- 13. Conducting Study tours, industrial visits, internship, field projects and joint consultancy work.
- 14. Support in actively engaging the students to help the delivery of the training and placements of students
- 15. All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate university entity.

METHOD OF IMPLEMENTATION

Specific activities to be undertaken under this Memorandum, which have been agreed to by the both parties are as follows

Facilities/ Staff Exchanges practice

- 1. The exchange of faculty to the mutual benefit of both institutions.
- 2. Each party will encourage continuing education and professional development for teachers, professors and academic staffs which may include.
- 3. Visits for studying teaching principles and methods
- 4. Faculties guides the projects of students from the host institution by the mutual consultation between the institution coordinators.

Student Exchange

- 1. Exchange students will be selected by mutual agreement between the home institution and the host institution.
- 2. An exchange student will be continue to be treated as full-time student at his/her home institution.
- 3. An exchange student will be considered as full-time "exchange" student at the host institution.
- 4. His /her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her academic advisor identified by the host institution.
- 5. The host institution will evaluate an exchange students' performance in each course or module, award a letter grade or marks, and issue a letter to that effect.
- 6. To avail travel expenses, students can apply for existing funding programs at their respective home institutions.
- 7. The exchange of students will pay tuition and other fees at their home institution.

Confidentiality:

The Sri Vidhya Mandir Arts & Science College and the Ganesar College of Arts & Science agree to hold in confidence of all information/ data designated by the institution as being confidential which is obtained from either institution or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other institution.

Coordinators:

Each institution shall appoint one member of its teaching/ research faculty to coordinate the programme on its behalf who will have responsibility for co-ordination and implementation of this agreement.

Tenure and Termination

- 1. This MoU shall be effective from the date of its approval by competent authorities at both ends.
- 2. The duration of MoU shall be for a period of Ten years from the effective date.
- 3. During its tenancy, the MoU may be extended or terminated by a prior notice of not less than six months by either party.
- 4. Once terminated, neither Sri Vidhya Mandir Arts & Science College nor Ganesar College of Arts & Science will be responsible for any losses, financial or otherwise, which the other institutions may suffer.
- 5. However, the termination of the MoU will not affect the interests of the students/ Faculty in any manner, who have been admitted to pursue a Programme under the MoU.
