This Memorandum of Understanding (MoU) is entered to between the Parties this 29th day of August 2019 which witnessed as hereunder.

- 1. The purpose of this MoU is to enhance overall quality and self-improvement of the Mentee Institution (LNC) by the Internal Quality Assurance Cell (IQAC) of the Mentor Institution (SVM) through a Hub & Spoke (H & S) Model under the UGC Scheme of PARAMARSH.
- 2. In an effort to experience the overall quality and self-improvement of the Mentee Institution (LNC), several programmes (Guest Lectures / Workshops / Trainings) will be implemented under the UGC Scheme of PARAMARSH. The themes of the programmes encompass:
 - i. To train Faculty and Staff for proper processes, documentation and presentation

- 3. The implementation of any or all the programmes will be separately negotiated and determined by the Parties by the way of separate agreement and subject to applicable UGC Regulation(s) of the PARAMARSH Scheme.
- 4. Implementation of the programmes under the UGC Scheme of PARAMARSH will continue up to the period prescribed by the PARAMARSH Scheme.
- 5. SVM (Mentor) and LNC (Mentee) affirm this MoU by signature of their officials duly authorized to enter into and to implement the same.
- 6. This MoU will become effective from the date herein mentioned above and shall remain valid for a period of two years unless either Party terminates the same on three month written notice to the other. Notwithstanding any such termination any Program that is being implemented under Clause 2 (ii) above shall continue till its full completion.
- 7. This MoU will be reviewed at the end of second year and subject to mutual consensus may be renewed on such terms and conditions as may be mutually agreed.
