- 1. Formulation and finalization of syllabus for the B.Sc. Zoology Programme for the academic year 2020-2021 and thereafter.**
- 2. To prepare the scheme of examinations and question paper pattern.**

RESOLUTIONS

1. The Committee appreciated the formulation of syllabus for B.Sc. Zoology Programme on Outcome Based Education (OBE) to meet out the criteria of the Educational Empowerment and Social Relevance.
2. In addition, the Committee suggested the following corrections/modifications/suggestions in the Programme Syllabus.
 - Programme Outcomes (PO's) and Programme Specific Outcomes (PSO's) to be incorporated.
 - Course Outcomes (CO's) to be restructured for all the Courses.
 - Recent reference books to be included in each Courses.

3. The Committee suggested to provide appropriated Course Title for some Courses.
4. The Committee suggested to restructure some of the Courses by incorporating and deleting selected topics.
5. The Committee suggested to give the Biostatistics and Computer Applications Course under Elective.
6. The Committee proposed to add the Biochemistry Course in the B.Sc. Zoology Programme Syllabus.
7. The Committee suggested to follow uniformity in providing Reference and Text Books for all the Courses of the Programme, such as Author Name (s), Book Name, Publisher, Edition, Volume Number and Year of Publication. Latest books to be included and link for e-books to be given.
8. Some of the spelling mistakes/typo errors found in the syllabus are asked to be corrected.
9. The Committee discussed about the Question Paper Structure of the theory examination and Unanimously Recommended to follow the following Question Paper Pattern.
 - ❖ Maximum marks for theory examination will be 100 marks, out of which 75 marks will be allotted for end semester examinations (ESE) and 25 marks will be distributed for internal examinations (CIA).
 - ❖ Part A in ESE will be conducted in the form of Objective Type Questions for 15 marks ($15 \times 1 = 15$ Marks).
 - ❖ For Part B, it is suggested to conduct the examination with 5 questions (each unit should contain one question). Out of the 5 questions, 3 questions to be answered ($3 \times 5 = 15$ Marks).
 - ❖ 5 questions in either or pattern (each unit should contain one either or type question) were suggested to ask in Part C ($5 \times 9 = 45$ Marks).


❖ Total duration of the exam will be 3 hours.

10. Internal Assessment (CIA) for 25 marks is suggested to be followed in the following manner

- a. Written examination (CIA Test) for 15 marks
- b. Assignment for 5 marks
- c. Students Attendance for 5 marks
