Memorandum of Understanding

1. Agreement

2. Purpose

Purpose of Agreement

The purpose of the collaboration between the parties is:

- e. Facilitate global partnerships to increase opportunities for the development of the concerned organisations.
- f. Developing cooperation, friendship and understanding between institutions and communities, Planning, initiating and implementing humanitarian, socio-cultural and economic development projects, programs and activities beneficial to concerned organisations.
- g. To facilitate learning and sharing of best practices from the industry to develop young leaders.
- h. To organise programmes to enhance the qualities of leadership, personality development, life skills, civic citizenship, and global understanding for sustainable development.
- i. To empower young leaders to promote students' active participation in community engagement to contribute to nation building.
- j. To enhance cross-cultural dialogue and knowledge exchange of concerned organisations.

3. General Area of Cooperation

The agreement will be automatically renewed further if concerned organisations have no objection and the agreement can be altered/modified with the consent of concerned organisations in writing when the need arise and the situation demands.

5. Confidentiality

- (a) Concerned organisations to the AGREEMENT have expressly agreed to hold the entire information and documents related to this programme as strictly confidential.

- (b) Concerned organisations shall use the brand name of the respective organisation in their promotional materials. Concerned organisations can discuss and execute branding issues on demand.

6. Facilitation of MOU

The MOU has been facilitated by Dinesh Gajendran from Audacious Dreams Groups (Foundation, Private Limited, Wealth Management) who will be acting as the focal point between all concerned organisations (Party A & B) concerned

7. Reports and Documentation

Concerned organisations agree to depute an executive to maintain the reports and documents of every work done for better coordination and mutual growth.

8. Finances

Finances related to the MOU and activities will be discussed and finalised on a project basis by concerned organisations

9. Amendment to the MOU:
