THE MEMORANDUM OF UNDERSTANDING DATED AT 21.07,2023

Between

Sri Vidya Mandir Arts & Science College (Autonomous) represented by Dr. N. Gunasekaran, Principal, SVMC having his office at Katteri – 636 902, Uthangarai, Tamil Nadu, hereinafter called the First party

PERU Foundation, Chennai, India represented by Dr. P. Mathialagan, Former Registrar, Tamil Nadu Veterinary and Animal Sciences University, Chennai and Chairman, PERU Foundation having his office at No: D 125, Sunny Vale Apartments, 351, Konnur High Road, Ayanavaram, Chennai – 600 023, hereinafter called the Second party.

do hereby agree to the following:

This Memorandum of Understanding (MoU) between Sri Vidya Mandir Arts & Science College (Autonomous), Katteri, Uthangarai, Krishnagiri (Dt.), Tamil Nadu and PERU Foundation, Vepery, Chennai, Tamil Nadu sets forth the agreement of the parties with respect to mutually benefit initiative to strength the training system and facilitate knowledge partnership for Academic and Extension Activities.

1. Objectives and Role of Partnership

- 1.1 Sri Vidya Mandir Arts & Science College (Autonomous), Katteri, Uthangarai, Krishnagiri (Dt), Tamil Nadu and PERU Foundation, Vepery, Chennai, Tamil Nadu partnership is constituted in mutual consultation with each other and based on the overwhelming positive response for academic collaboration through extension activities, training programmes, field / exposure visit and internship programmes for mutual benefit of both the parties of the partnership concerned.
- 1.2 The Primary Objective of the partnership is to provide a platform for students for catalyzing joint initiatives to launch development programmes through training programmes, field visit and internship programmes for the benefit of students. Such knowledge sharing is not merely in terms of the number of human resources required for the types of extension activities, but is also intended to be much deeper with long-term strategic goals and advantages for both the parties.

1.3 The academic and extension activities would involve:

- Pre-service training the students to create awareness pertaining to extension activities for the benefit of the society.
- Enhancing the knowledge and skill of students through various training programmes and field visit / exposure visit.
- Providing opportunities to the students to pursue Internship Programmes and exposure for job training in selected organizations.

2. Member of the partnership committee

2.1 The partnership committee will comprise representatives from Sri Vidya Mandir Arts & Science College (Autonomous), Katteri, Uthangarai, Krishnagiri (Dt), Tamil Nadu, and representatives of the PERU Foundation, Chennai with a term of three years with subsequent renewals and modifications for a further period of three years, subject to renewal of this MOU.

Two Members drawn from Sri Vidya Mandir Arts & Science College (Autonomous) and PERU Foundation.

- 2.2 The partnership Committee would meet once every quarter to take stock of the progress and give directions to the various clauses for implementation.
- 2.3 Sri Vidya Mandir Arts & Science College (Autonomous) and PERU Foundation would provide dedicated staff to work very closely to achieve the goals of the partnership. The Members of PERU Foundation and Sri Vidya Mandir Arts & Science College (Autonomous) will be the coordinators for the Partnership Committee.
- 2.4 The Agreement shall commence on 21.07.2023 and shall continue in force until terminated by mutual consent after prior written notice by either party to the other party. The termination will be subject to compliance to the completion of all commitments made. Notwithstanding any such termination, both parties shall ensure that all activities in progress are completed successfully.
- 2.5 This MoU will be valid for a period of three years from the date of signing of this MoU. After the expiry of this period, the MoU may be extended for further three years based on mutual interest.
