WHEREAS:

(A) RV College of Engineering (RVCE) is one of the leading Engineering education institutions that offers quality engineering education and conducts research in various branches of Engineering for advancement of learning and dissemination of knowledge in these disciplines.

(B) Sri Vidya Mandir Arts and Science College (SVMC) (Autonomous) is one of the leading arts and Science College in Tamil Nadu that offers quality education and conducts research in various branches of Arts and Science Streams.

(C) Sri Vidya Mandir Arts and Science College has approached RVCE to be an academic partner of SVMC for the purpose of jointly collaborating for student internships, research, invited lecture, FDP with mutual understanding in the fields of **Mathematics** and **Computer Science**.

PURPOSE

1. The purpose of this MOU is to confirm the intent of the Parties to explore the possibility of mutually beneficial academic research collaborations in **Basic Science and Engineering and Humanities** areas. - (v) Placement training and opportunities
- (vi) Soft skills training
- (vii) Jointly organizing Seminars and Conferences

Manner of implementation

3. The collaboration contemplated by the MoU will be implemented by:

- a. The exchange of researchers
 - b. The exchange of scholarly and pedagogical materials
 - c. The coordination of collaborative research programs
- For the purposes of this MoU, "researchers means the following."

- a. Faculty members
- b. Doctoral/postdoctoral fellows
- c. Undergraduate/Postgraduate students participating in the exchange for the purpose of internship, training programs and research collaborations for a period (15 days or one month).

4. Parties agree that any information exchanged between them that is proprietary and/or confidential shall be kept confidential. The parties will mutually discuss and agree on the confidentiality terms and execute a separate Non-Disclosure Agreement or any other agreement as required.

5. All publicity activities, including announcements in any media relating to this MoU and collaborations arising from this MoU, shall be subject to mutual agreement, in writing, between the Parties.

6. The Parties agree that this MoU is not intended to create a legally binding contractual relationship between RVCE & SVMC & or any other entity or government agency and shall not be construed to provide a private right or cause of action for or by any person, entity, or government agency.

7. Should any question or situation not expressly provided in this MoU arise, the matter shall be resolved by joint consultation between RVCE and SVMC in a spirit of mutual co-operation.

8. Parties will not entertain any claim for damages arising from whatsoever cause or reason in connection with the provisions of the MoU.
