MEMORANDUM OF UNDERSTANDING

Gunasekaran**, hereinafter referred to as SVMASC, which expression shall unless repugnant to the subject or context thereof in this Agreement shall include its executors, successors and permitted assigns of the FIRST PART.

And

PG and Research Department of Biochemistry, Sacred Heart College (Autonomous), Tirupathur Tamil Nadu represented herein by its Authorised Signatory, Dr. D. Maria Antony Raj, hereinafter referred to as SHC which expression shall unless repugnant to the subject or context thereof in this Agreement shall include its executors, successors and permitted assigns of the SECOND PART.

Whereas, PG and Research Department of Biochemistry, SHC is in the field of imparting Education to Students and Whereas, PG Department of Botany, SVMASC is also an education institution functioning from Krishnagiri, Tamilnadu.

The Both institutes have been referred individually as Party and jointly as Parties.

AND whereas PG Department of Botany, SVMASC proposes to enter into this MoU with PG and Research Department of Biochemistry, SHC for the purpose of developing a full-fledged content Management system and other area. This MoU is purely for academic purpose only.

AND whereas the parties to this MoU agree that this MoU shall be valid for a period of three (3) years from the date of signing of this MoU (hereinafter referred to as the period)

Set forth below is the understanding between SHC and SVMASC

- SVMASC Botany Department faculty members will be trained from time to time depending upon the requirements of the SVMASC Botany Department and at the convenience of the faculty members of Biochemistry Department, SHC.
- 2. In order to promote further student exchange, both parties shall actively consider the exchange of teaching faculty members and students. Such exchange shall be the subject of ad hoc consultation in future in accordance with the needs and feasibility and based on mutual agreement between the parties.
- Senior faculty members of Botany, SVMASC will share their expertise in the design of curriculum and act as subject expert during Board of Studies.
- 4. SHC will share its domain expertise to the SVMASC Botany faculty members, provide its research expertise in scientific publications in reputed journals, study programmes, projects, organizing seminars, conferences, workshop, symposium, FDP and other academic and research activities.
- Prices and payment: There are NO Monetary terms or value attached or exchanged in MoU, which is purely for the purpose of promoting Academic Excellence.
- Periodicity: This MoU is valid for the period of three (3) years from the date of signing by both the Parties or may be reviewed and renewed on mutual consent of both Parties thereafter.

7. Termination: Either of the parties may terminate the Contract voluntarily if it so wishes or if it defaults or breaches any of the terms and conditions of this MoU, by giving minimum of sixty (60) days' notice to the defaulting party.

Entire agreement: Botany Department, SVMASC and Biochemistry Department, SHC acknowledge that they have read this agreement, understood it and agree to be bound by its term and further agree that it is complete and exclusive statement of the agreement between the parties, which supersedes all proposals oral or written, and all others communications between the parties relating to the subject matter of this agreement.

Botany Department, SVMASC and Biochemistry Department, SHC look forward to implementing this mutually beneficial agreement in the common interest of helping students of the both Departments.
